## Family Rehousing and Stabilization Program (FRSP) Task Force Customer Listening Session– Annotated Notes September 10, 2019 1 pm – 3 pm Triumph Short Term Family Housing

## Format: Focus group

- 1. Welcome and Introductions
  - Each attendee introduced themselves and stated how long they had been placed at the Triumph Short Term Family Housing.
- 2. FRSP program overview and Task Force process
  - Tamitha M. Davis-Rama, Administrator, DHS Family Services Administration
  - Noah Abram, Deputy Administrator, DHS Family Services Administration
  - Barbara Poppe, consultant and facilitator
- 3. Focus Group questions:
  - a. Are you or have you ever been enrolled in FRSP?
    - All families have been referred and accepted in Rapid Rehousing.
  - b. What will be the most useful part of the FRSP program to your family?
    - Rent subsidy
    - Learning how to budget
  - c. Are you enrolled in TANF? Do you receive TEP services?
    - All, but one, families stated they are enrolled in TANF and are receiving TEP services.
    - One family has \$434/month income from SSI and has limitations with not being able to work.
    - The TEP case worker helps step by step.
    - "I've been homeless for 8 years, and during that time, I was never unemployed until I had a premature child. I am currently exempt from TANF, and don't want to be in rapid rehousing because I'm not working with a TEP provider. I choose to be exempt".

- "It is easy to find a job, but hard to find a career".
- d. How long should the FRSP program be?
  - Based on each individual family's needs
  - Based on each individual family's income
  - Not everyone can keep a stable income
  - 6 12 months to start with an ongoing review to assess what families need
  - Job programs, job readiness, job placement
- e. How much do you have to contribute to the rent?
  - 40-60% of the rent plus utilities
  - "When you have \$500/month and you have to 40% for rent, it is hard to think about. There is no money left at the end of the month".
  - It makes me depressed because we want things for our children.
- f. What help do you need when you are moving into an apartment? What services would be helpful?
  - Affordable units
  - Child care
  - Mental health care
  - Safety in neighborhoods
- g. What would you like to see improved about the FRSP program?
  - Rent in DC is too expensive; MD is cheaper and has better housing and a different network. Possibility to use the subsidy in MD.
  - Budgeting workshops
  - Credit repair
  - Job readiness programs
  - Education programs (high school and GED)
  - Trainings that lead to employment
  - Possibility to receive housing subsidy voucher
    - Decrease the section 8 housing voucher waiting list.
    - Section 8 enables families. If you give them a voucher, they will never improve their living situation
  - More assistance from case managers in unit viewing. Families were met with a lack of respect from landlords and property managers. It would be better if case managers went to view units.
- h. When should a family be exited from the FRSP program?
  - Exits should be based on individualized care for each family
  - 16, 24 or up to 36 months
  - After a family can successfully maintaining their unit.
  - Having an efficient budget.
  - Based on efforts families are showing effort vs. someone not trying
